### TERMS AND CONDITIONS

<u>Placing orders</u>-Orders may be called in to Customer Service, faxed, emailed, or placed through the internet. We are open Monday-Friday 7:30am-6pm. Shipping of orders will cut off on Monday and Tuesday at 5pm and 5:30pm Wednesday-Friday. All orders placed via our website are reviewed by Customer Service before shipping to ensure accuracy.

<u>Terms</u>- Net 30 days from date of invoice subject to credit approval. A 1-1/2% per month interest charge is applied to past due amounts. Shipment of new orders may be withheld if payment terms have not been met. Credit privileges may be suspended for any account where there is a past due balance.

<u>Shipping policy-</u> Shipments will be made "best way" at the discretion of Victor Medical Company. A \$1 service handling fee will be added to each order processed. Special order items and items shipped directly from the manufacturer (drop shipments) may be subject to freight charges. If the customer requests special shipping, handling, or routing, shipping costs will be added to the invoice and are the customer's responsibility. Customers outside of WA, OR, CA, NV, AZ, and UT will be subject to an out of region shipping fee of \$10.50 for orders that are under \$150 before tax.

<u>Pricing and Quotations</u>- All pricing and terms are submitted without obligation and are subject to change without notice. All orders are subject to acceptance at prices in effect at the time of shipment.

<u>Claims for Damages/Shortages in Transit- Claims</u> for damages, shortages, losses, or pilferage in transit are the responsibility of the receiving party and must be reported within 48 hours of receiving the shipment. Contact VictorMedical Company Customer Service and report any discrepancies or damages at 800.888.8908 within 48 hours.

<u>Shipping Errors</u>- Shipping errors will be accepted for full credit provided Victor Medical Company Customer Service is notified within 48 hours of receipt.

<u>Return Goods Policy</u>- Credit will not be issued for returned goods without prior authorization and receipt of return goods authorization (RGA) number from our office. Product must be returned within 30 days of returned goods number assignment. The return goods'number must appear on the shipping label and all paperwork accompanying the return.

Victor Medical Company will only accept returns for the following:

- Product was shipped to the customer with less than 6 months dating.
- · Product involved with shipping errors by Victor Medical Company, if notified within 48 hours.
- Product that has been recalled by the manufacturer that was purchased through Victor Medical Company.
- Outdated product that is not a Federal Legend Human Pharmaceutical that can be returned to the manufacturer by Victor Medical for credit.

#### Items not eligible for return:

- > ALL special-order Federal Legend Human Pharmaceuticals.
- ➤ Any opened container whether within expiry or expired.
- ➤ Any product where the container or label has been defaced rendering it un-saleable.
- ➤ Any product Victor Medical cannot return to the manufacturer for full or partial credit. Any other item accepted for return by our office will be subject to a 25% restocking fee
